

Detainees on Electronic Monitoring by Lead Charge and Length of Current EM Stay as of September 03, 2026

Charge Description: Brief description of the criminal statute the detainee is charged with violating. This information is limited and frequently does not provide a complete picture of the charges and cases the inmate may have faced. This information is provided to CCSO via a Mittimus document from the Clerk of the Circuit Court, which may not include all charges associated to a specific case. The official source for all charges and related information is the Clerk of the Circuit Court, as CCSO's offender management system is limited to Mittimus information. Please note that the listed charges may include attempts.

Length of Current EM Stay: Defined as the number of consecutive days that the detainee has been held on Cook County Sheriff's Electronic Monitoring (EM), as of the date of this data. The detainee may have spent some time in Sheriff's Custody in the jail for additional days prior to being placed on EM, **but this length of stay definition reflects only continuous time on EM and does not include any time the detainee previously spent in jail on their current booking.**
